ENTRIES:

Each current Franchise in good standing is eligible to enter up to 10 male and 10 female boxers. Non-citizens of the US <u>are eligible to compete</u> in the 2025 National Tournament. ALL boxers must have a minimum of 10 bouts and meet the age determination requirement to compete at the National Tournament. A Bout Exception Form may be completed with authorization from the Boxer's coach, Franchise Delegate and Golden Gloves of America President. The Bout Exception Form must be submitted 7 days prior to the first Golden Gloves competition event. Franchise Team Rosters must be emailed to the Executive Director immediately following your franchise region tournament and no later than <u>THURSDAY MAY 1, 2025</u>. Any changes to Team Rosters must be turned in to The Headquarters Office on <u>Saturday May 10th from 12:00pm-9:00pm</u>. The Headquarters Office will <u>NOT</u> be open on Sunday May 11th as this date is reserved for draw/bracketing, bout sheet distribution and boxers/coaches technical meeting.

WEIGHTS:

Twenty (20) weight classes will be contested at the National Tournament.

MALE: 110, 121, 132, 143, 154, 165, 176, 187, 198, 198+ **FEMALE:** 106, 112, 119, 125, 132, 143, 154, 165, 176, 176+

BOXER AGE REQUIREMENTS:

Boxers ages 18 thru 40 are eligible to participate. All boxers must be at least 18 years of age prior to competing in any Golden Gloves advancing event and not yet 41 before May 18, 2025.

FRANCHISE DELEGATION:

A full Franchise Team Delegation is comprised of 26 members: 1 Delegate, 1 Alternate Delegate, 20 boxers, 2 team coaches, 2 officials. No franchise may participate in the tournament with less than eight (8) qualified contestants. The Executive Committee may waive this requirement based on extenuating circumstances which judgment shall be at its sole discretion.

TEAM REGISTRATION/CHECK-IN:

BOXER PASSBOOKS AND FINAL TEAM ROSTERS will be submitted to the Headquarters office located at Doubletree Hotel Saturday May 10th between 12:00pm-9:00pm. The Headquarters Office will close at 9:00pm on Saturday May 10th and remain closed on Sunday to boxers and delegates. Late franchise team arrivals will not be entered into the tournament. Franchise Delegation credentials will be issued to Delegates when the team is registered at the Headquarters Office on Saturday May 10th. Credentials will be issued for the Delegate, Alternate Delegate, 2 guests, and boxer entrants who are registered by the Franchise Delegate.

COACHES REGISTRATION/CHECK-IN:

All coaches not serving as a Franchise Team Coach, must register online through webpoint. Credentials for all Coaches will be issued at the Headquarters Office on Saturday May 10th 12:00 noon - 9:00pm, Sunday May 11th 10:00am-2:00pm, and daily 7:00am-9:00am during weigh-ins ONLY. No Coaches credentials will be issued outside of these times.

OFFICIALS REGISTRATION/CHECK-IN:

All officials not serving as a Franchise Team Official, must register online through webpoint. Credentials for all Officials will be issued at the Headquarters Office on Saturday May 10th 12:00 noon - 9:00pm and Sunday May 11th 10:00am-2:00pm. Any Officials arriving outside of the registration time MUST CONTACT the Tournament Chief of Officials Jeanne DePriest at jhd4boxing@msn.com or (970) 978-5188.

All participants must present their credentials for admission to the venue.



DRAW AND BRACKETING:

Live Draw and bracketing will take place through Instagram Live on Sunday May 11th at 12:00 noon.

COACH/BOXER/DELEGATES TECHNICAL MEETING:

Sunday May 11th 3:00pm at Cox Convention Center

WEIGH-INS AND PHYSICALS:

Monday May 12th through Saturday May 17th weigh-ins will be held at Doubletree Hotel at 7:00am sharp each day. Physicals will take place immediately following the Boxer's weigh-in.

COMPETITION SESSIONS:

One session daily Monday May 12th thru Friday May 16th 5:00pm and Saturday May 17th 4:00pm

RINGS-ROUNDS:

*3-minute rounds are mandatory in all Golden Gloves Tournaments leading up to the National Golden Gloves Tournament.

Monday-Wednesday 4 rings, 3-minute rounds
Thursday 3 rings, 3-minute rounds

Friday 2 rings, 3-minute rounds

Saturday 1 ring, 3-minute rounds

SCORING SYSTEM:

ESS Scoring System

UNIFORMS AND EQUIPMENT:

All participants must wear team uniforms with team colors as provided by their Franchise. All Open Elite boxers are required to wear open-faced competition approved headgear in all Golden Gloves tournaments. (Sub-Franchise, Regional and National tournaments.) Coaches must have their own corner equipment. Competition gloves will be provided at the National Tournament and must be used by all boxers in the competition. Headgear <u>will not</u> be provided.

RULES:

USA Boxing National Rulebook with Golden Gloves Rules Modifications will be used in the conducting of the Tournament. Additional policies and procedures as contained in the Golden Gloves of America By-Laws and Policies and Procedures shall prevail over this tournament.

**All rules and policies as outlined in this fact sheet are applicable at all Golden Gloves competitions (i.e. sub-franchise and regional events.)

**It is highly recommended that you utilize the online Webpoint registration for your sub- franchise and regional tournaments. This is a very effective tool to aid in streamlining athlete information at both the local and national level.
